Why or why not?

- · Scattered resources need to be combined.

- It is the only way to move forward. All agencies need to <u>promote</u> development by the same plan.
- The RR goal appears troubled at best. Unclear what products there are to be shipped. Government subsidizes road transportation, Caltrans, oil industry. There is no short-haul shipping.
- Unity and collaboration are absolutely necessary for success.
- It's the only way it will work.
- This does have deliverables and should be adapted as action plan for HBWOC.
- Must happen
- As discussed, any investors/stakeholders will want to see a unified plan.
- Thousands of reasons!

- Political stupidity.

Challenges, continued

- Our Harbor District commissioners are frightened of what we are proposing and are avoiding it.
- Potential for frivolous lawsuits; small factions trying to stalemate/stall plan approval.
- The Harbor District Commissioners are the biggest obstacle to revitalizing our harbor.
- Convincing all agencies to come together for 1 plan.
- Collaboration!
- The Harbor District---and no connection to the national rail network.
- RR construction.

4. What suggestions do you have for dealing with those challenges?

- Further develop the unified plan as presented
- Vote
- Huge turn-out for Eureka City Council race...NOW!
- Draw an org chart of who is going to make decisions, then figure out why these things haven't been achieved yet, really.
- Educate the entire public about the jobs and benefits which would result.
- Vote them out.
- Trucking.
- Massive public outcry for the need for action for jobs!
- Decision makers must prove they have backbone.
- Elect Harbor Commissioners that share this vision.
- Change the Harbor District elected officials and rally the business community for the E/W rail feasibility study.
